

#### as it gotten harder for you to share your pro-life beliefs with others?

Even when a personal and truthful claim is made, there seems to be a need to broach unpopular topics delicately or we risk evoking a strong emotional response and promptly being "cancelled". A case in point is NFL star Harrison Butker whose inspiring and encouraging commencement address drew fire and brimstone from an audience he wasn't even addressing!

Unfortunately, these are the times we live in. And being pro-life can get you cancelled in some circles quicker than you expect, which can be a temptation to remain quiet and inconspicuous about our beliefs. But that must not deter us from being bold in proclaiming the gospel of life, especially because lives are at stake here.

#### So how can we keep the conversation about life going in an increasingly intolerant culture? Dialogue.

While most of us are not given a stage like Harrison was, we are given everyday relationships and situations. Speaking up in either setting takes an immense amount of courage. And some skill, that can be easily acquired.

Dialogue remains a means of exploring the subject of discussion together, educating and informing ourselves and the other, and providing thought-provoking inputs that challenge both parties to stretch their understanding and forbearance for one another.

"I think differently about this and would like to understand where you are coming from." Conviction and openness - that's a great place to begin with. When it comes to being pro-life, our convictions are our greatest strength and ally. Combine that with an openness to the experience of others and you have a winning formula to influence others!

#### Here are some ways we can dialogue better with those who disagree with us:

#### **Posture yourself as a learner:**

A conversation about life does not have to be a debate. Whether you're talking to someone who has taken the middle ground regarding life issues or a zealous pro-abortion activist, there's always something unique that can be learned. The key is to actively listen. Find out what your audience believes. Ask pertinent questions: Where do they get their information from? What influences them? What common ground can you find? Genuinely get to know the heart and mind of the person you are conversing with. Help them see you care about them, not just what they believe in.

#### Provide a space to explore difficult thoughts:

One of the hardest parts of dialogue is to unlearn our instinctual other people's strong convictions. People generally arrive at conclusions based off of their own experiences and of those in their inner circles. Pro-choicers or proabortion folks may have never had an opportunity to explore their beliefs in a conflicting yet safe environment, free from shame or judgment. The pro-life people who have influenced me most are those who aren't afraid of the big questions, who are willing to be honest about the hard stuff and yet gracefully lead back to the idea that all human life is valuable and that the beauty of life trumps all arguments for death.

#### **Speak into thoughts expressed:**

It is important to validate the truth in your opposition's perspective even if it's only partial. And once you're able to do that, you can proceed to fill the gap with the whole truth. Let me illustrate with one of the classic abortion beliefs "a fetus is just a clump of cells." We can begin by acknowledging that yes, in the earliest stages of human development we are all a small clump of cells. And then, proceed to introduce them with information that they may not have had before: "...but by the sixth week of our formation, we are already distinguishable in our form with a small beating heart and developing head and spine. These are parts of us that you and I will have for the rest of our lives!" You'd be surprised at how uncommon knowledge like this is!

#### **Respond in context:**


I have sometimes observed a disconnect between the points our pro-choice friends are making and the case for the unborn or elderly that we present. Approaches to arguments for and against life can be multi-faceted - political, legal, medical, scientific, philosophical, moral or spiritual. Those who support assisted death in any capacity are usually arguing within one or more of these realms, but not all. The good news is that the case for life stands no matter how you approach it and is always consistent. While it can seem easier to always defend life from one perspective alone (and for most it is either scientific or faith related), it can be insufficient in persuading others into the cause for life. Our job is to stay on topic and clarify our position within the field of discussion.

Of course, there will always be some who are unwilling to engage or remain unconvinced but the goal of dialogue is to present the ideas and keep the line of conversation open. Give them something to think about and then allow them to arrive at their convictions whenever and however they are ready.

Ultimately, the essential element in having effective and fruitful conversations that invite others in is to expand our own convictions for life into all areas, confident that the truth of life is self-evident and established unlike the mental gymnastics that is required to build a case for death. All we need to do is show up in our everyday life armed with this knowledge and speak up when an opportunity presents itself.

## PRESIDENT DONALD J. TRUMP

2017 — 2021

#### ★ TRUMP RECORD ON LIFE ★

■ **SUPREME COURT:** President Trump appointed Neil Gorsuch, Brett Kavanaugh, and Amy Coney Barrett to the U.S. Supreme Court. These appointments are consistent with the belief that federal courts should enforce the rights truly based on the text and history of the Constitution, and otherwise leave policy questions in the hands of elected legislators.

#### ■ MEXICO CITY POLICY:

President Trump restored the "Mexico City Policy," which prevents tax funds from being given to organizations that perform abortions or lobby to change the abortion laws of host countries. He later expanded the policy as the "Protecting Life in Global Health *Policy*" to prevent \$9 billion in foreign aid from being used to fund the global abortion industry.



#### **ABORTION FUNDING: In**

2017, President Trump issued a statement affirming his strong support for the No Taxpayer Funding for Abortion Act, saying he "would sign the bill." The bill would permanently prohibit any federal program from funding elective abortion.

FUNDING ABORTION **PROVIDERS:** In 2018, President Trump's Health and Human Services Department issued regulations to ensure Title X funding did not go to facilities that perform or refer for abortions. In 2017, President Trump signed a resolution into law that overturned an eleventh-hour regulation by the Obama administration that prohibited states from defunding certain abortion facilities in their federally-funded family planning programs.

**■ PROTECTING PRO-LIFE POLICIES:** President Trump had pledged "to veto any legislation that weakens current pro-life federal policies and laws, or that encourages the destruction of innocent human life at any stage."

• **APPOINTMENTS:** President Trump appointed numerous prolife advocates in his administration and cabinet including Counselor to the President Kellyanne Conway, Secretary of State Mike Pompeo, Secretary of Education Betsy DeVos, Secretary of Energy Rick Perry, United Nations Ambassador Nikki Haley, Secretary of Housing and Urban Development Ben

Carson, and Chief of Staff Reince Priebus.

 DEFUNDING PLANNED **PARENTHOOD:** President Trump supported directing funding away from Planned Parenthood, the nation's largest abortion provider. In a September 2016 letter to prolife leaders, he noted that "I am committed to... defunding Planned Parenthood as long as they continue to perform abortions, and re-allocating their funding to community health centers that provide comprehensive health care for women."

#### ■ INTERNATIONAL **ABORTION ADVOCACY: The**


Trump Administration cut off funding for the United Nations Population Fund due to that agency's involvement in China's forced abortion program. Additionally, President Trump instructed the Secretary of State to apply pro-life conditions to a broad range of health- related U.S. foreign

#### **■ PROTECTING THE**

**UNBORN:** President Trump supported the Pain-Capable Unborn Child Protection Act. This legislation extends protection to unborn children who are at least 20 weeks because by this point in development (and probably earlier), the unborn have the capacity to experience excruciating pain during typical abortion procedures.

## PRESIDENT JOSEPH R. BIDEN

2021 — present

#### ★ BIDEN RECORD ON LIFE ★

#### ■ MEXICO CITY POLICY:

In one of his first acts in office, President Biden repealed the Trump-Era "Protecting Life in Global Health Assistance" or "Mexico City Policy," which prevents tax funds from being given to organizations that perform abortions or lobby to change the abortion laws of host countries.

#### ■ PROMOTING ABORTION-**ON-DEMAND UNTIL BIRTH:**

President Biden strongly supports the radical so-called Women's Health Protection Act. This legislation would essentially remove all legal protections for unborn children on the federal and state level and prevent future protections for unborn children.

#### ■ CHEMICAL ABORTION:

President Biden's Food and Drug Administration (FDA) suspended protections established for women undergoing chemical abortions, such as seeing the abortionist in person. The in-person requirement ensured that complications, such as an ectopic pregnancy, are ruled out in advance of a woman undergoing a chemical abortion. Mifepristone, the "abortion pill," has no effect on an ectopic pregnancy and leaves the woman with this life-threatening medical condition. The FDA will also permit pharmacists to dispense chemical abortion drugs, and will permit these dangerous drugs to be sent through the mail.

#### • FUNDING ABORTION **PROVIDERS:** In April 2021,

President Biden's Health and **Human Services Department** overturned the Trump Administration's "Protect Life Rule" on Title X family planning funding. The new Biden Rule means that millions in Title X funding will flow to facilities that perform or refer for abortions.

#### • FETAL TISSUE RESEARCH:

Under President Biden, the National Institutes of Health reversed Trump Administration regulations and announced that it will again fund intramural research and will no longer convene the Human Fetal Tissue Research Ethics Advisory Board for

extramural research.

#### **ABORTION FUNDING:**

Though he long supported the Hyde Amendment in the past, as a presidential candidate, President Biden changed his position in 2019. President Biden is now on record in support of eliminating the Hyde Amendment which prevents the use of federal funds to pay for abortions except in cases of rape, incest or to save the life of the mother.

By Executive Order, President Biden directed his administration to consider actions to advance access to abortion, including an effort to encourage states to apply for Medicaid waivers to pay for abortion travel.


#### ABORTION FUNDING IN THE MILITARY: Biden's

Department of Veterans Affairs has announced they will pay for and provide abortions for "health reasons," defined broadly as to be for any reason. This has been statutorily prohibited since 1992. Under the Biden Administration, the Department of Defense announced it will pay the travel and transportation costs for military members and dependents to travel to obtain elective abortions.

■ **APPOINTMENTS:** President Biden has surrounded himself with stalwart pro-abortion public officials, including Vice President Kamala Harris. His cabinet appointments include proabortion former congressman and former California Attorney General Xavier Becerra to head Health & Human Services, pro-abortion activist Samantha Power to head the U.S. Agency for International Development and Chiquita Brooks-LaSure, who consulted for Planned Parenthood during the 2020 elections, to lead the Centers for Medicare and Medicaid Services.

**SUPREME COURT:** President Biden promised to only appoint justices who support a right to abortion, nominating Ketanji Brown Jackson to serve on the Supreme Court. Her nomination was strongly backed by Planned Parenthood, NARAL, and other abortion groups.

#### ROBERT F. KENNEDY, JR

#### ★ KENNEDY RECORD ON LIFE ★

#### Abortion Without Limits:

"Mr. Kennedy's position on abortion is that it is always the woman's right to choose. He does not support legislation banning abortion." - Kennedy spokesperson (Politico, 8/13/23)

• Funding for Abortion **Providers:** Kennedy supports taxpayer funding for abortion providers, including Planned Parenthood, the nation's largest chain of abortion clinics.

"You can't tell poor people that, because they don't have the money, they have to bring a baby to term," Kennedy argued. (The American Conservative, 8/14/23)

- Roe v. Wade: "I am a firm supporter of the principles laid out 50 years ago in Roe v. Wade," Kennedy declared. (New York Post, 8/14/23) Roe and companion case Doe v. Bolton effectively legalized abortion on demand nationwide and rendered unconstitutional meaningful protections for unborn babies.
- **Dobbs v. Jackson:** The Supreme Court's ruling in Dobbs v. Jackson (2022) returned abortion policy to the American people and their elected representatives. Kennedy opposed this ruling. "If the courts do not overturn *Dobbs v*.

Jackson and restore abortion rights, I will support legislation to accomplish the same," Kennedy told the New York Post (8/14/23).

- **Abortion Drugs:** Chemical abortions account for more than 60% of abortions in the U.S. annually. A Kennedy statement to the Washington Post (11/8/23) confirmed, "Kennedy supports the Food and Drug Administration (FDA) approval of the abortion drug mifepristone."
- Late Abortions: Kennedy does not support legal protections for unborn children at any stage, even late in pregnancy. "I've seen late-term abortion pictures and they're horrifying. So, I understand the people who want them banned, but I also am too skeptical of government to believe that it should be the one that should be dictating bodily decisions," Kennedy stated in an interview with journalist Peter Bergen (10/13/23).

Kennedy told Reuters he thought every abortion was a "tragedy" but that it should be a woman's right "throughout the pregnancy." (Reuters, 3/20/24)

Self-Described "Pro-Choice": Kennedy labels himself "prochoice." At a WMUR townhall, Kennedy articulated that ultimately he did not want to "be in a position where I'm telling a woman she has to bring a child to term that she doesn't want." (WMUR-9, 6/23/23)

I am thankful because you loved me enough to give me life, and I hope one day I will be able to tell you how God worked in my life and how much He loves you too.


coveted first place Madeline Johnson with her speech

he walks into the clinic, scared and alone. The receptionist escorts her to a room where she waits for a doctor. Online she saw that the thing inside her was a fetus-some tissue she could choose to remove if she wanted. What she does with her body is her choice. No one can tell her what to do. That's what the doctor says as he preps for the simple procedure that won't take long. Her life will be back on track in just a bit. Problem solved.

But on the way into the clinic she saw something she can't forget. A woman held a sign with a Bible verse on it: "...I have set before you life and death...Therefore choose life, that you and your offspring may live..." (The Bible, Deuteronomy 30:19; emphasis added).

And something clicks in her mind.

She does have a choice! She can choose life!

The doctor tells her to put her feet in the stirrups, but instead she gets off the table and leaves the room. She has made her choice.

Pregnant mom in distress: know that God gives you a choice. Know too that your choice affects two lives: yours, because that simple procedure will change your world forever; and the tissue's too, because that clump of cells has a name, a personality, a special laugh, and hopes and dreams. Your decision will affect two people, my friend.

But wait—what about the tissue's father? Research shows that fathers can struggle with posttraumatic stress disorder, anxiety, depression, and other adverse effects when their children are aborted. That's three people, then.

But what about the grandparents? They will live with unending sorrow over the grandchild (or is it the grandtissue?) they will never know.

Perhaps a few more than two people are affected.

Like the *tissue's* future spouse, who missed out on their soulmate because their soulmate was aborted. And their future children and grandchildren, who will never exist. What about all the cancer patients whose disease that tissue never cured? The people that would have been aided by the foundation the tissue will never start? The citizens who will never benefit from the tissue's tenure as president of the United States? Or maybe, just maybe, it isn't a tissue at all. It's a baby that never got a chance to live.

All because of the sterilized tweezers that annually take the lives of more people than heart disease does. The tweezers that have murdered enough American babies to equal the population of Argentina.

But don't forget! Every mother has a choice!

Hopefully, as they decide, they will remember that their choice means life or death for themselves, the baby, dad, grandparents, children, grandchildren, and the world.

#### Choose life.

However, not everyone is a pregnant

woman faced with a terrifying decision between life and death. Why do we—the already pro-life community-need to hear this?

Pregnant mothers aren't the only ones with a choice. You—the average pro-life person—have a choice. You can sit back and do nothing, or you can make your life count for something!

After all, how will that birth mother know about her option to choose life for her baby, if you don't tell her? How will pro-life lawmakers across the country amend state constitutions if you don't elect them? How will those who have been affected by abortion recover if you don't hold them, tell them they are forgiven, and offer them hope in Jesus? Someone chose life so you could sit and read this today. Make that life count. Be ready to tell a scared mother that she can choose life. Get involved with a crisis pregnancy clinic. Pray outside a Planned Parenthood center. Talk to your kids about why you are pro-life. Buy baby supplies for someone you know who can't afford them. # LOSING A SIBLING TO ABORTION:

Sibling Survivors can really feel so ashamed that they are alive, and I certainly did.

rista Corbello is a very articulate young woman with a heart for life. She exudes joy and an eternal hope that pulses through every word she speaks. There is a depth to her understanding of the effects of abortion on siblings whose parents made that terrible choice. After all, it comes from her own lived experience.

Krista made her entry into the pro-life movement through a Right to Life job through which she was engaged in youth education in the state of Louisiana. She had been giving pro-life presentations long before she uncovered her own

Having been raised without her biological father in the picture, Krista always associated the question marks surrounding her life with just not knowing him.

"My story of origin unfolded more over the course of those three and a half years (that I was doing prolife ministry)," she says. She met her biological father for the first time while in college and eventually came to find out about the abortion her father had with a woman he dated after his relationship with Krista's mom ended.

"It felt like some parts of my life made sense," Krista shares. Along with the discovery came what she describes as an "elongated version of PTSD".

There is a term for this in psychology: Post Abortion Survivor Syndrome (PASS).

Krista's work now became more painful and personal following the revelation. It was no longer a biological, medical or philosophical matter for education. "It became difficult to talk about the medical abortion methods thinking about the fact that my sibling had died by one of these ways."

What she was experiencing catapulted her into starting her own ministry Even This Way to help other siblings through the process of grieving and healing from the knowledge of losing a sibling to abortion.

"Abortion is often disguised as a good choice," Corbello continues,

"But this private choice can be detrimental to the mental health and especially the spiritual lives of surviving siblings"

Even This Way began as a capstone project for her Master's program in Psychology at Divine Mercy University. Delving into research available on sibling loss, Dr. Philip Ney's study on maternal pregnancy loss became foundational to her work.

Dr. Ney's 2010 research pointed to a significant difference in what siblings experience when their parents had miscarriages and abortions. He found that sibling survivors of abortion feel unworthiness, doom, lack of meaning in life, existential crisis, survivor's guilt and a struggle to embrace life fully.

According to Ney, "As a comparison, symptoms of those who lost siblings through

miscarriage are quite different. Interestingly, although they feel angry, they feel life is worth living and they have no trouble with interpersonal relationships."

Ney provides this "inadequate analogy" to illustrate why miscarriage survivors feel glad to be alive while abortion survivors feel they don't deserve to be alive: Picture a family of four on a seaside vacation walking along an unguarded cliff when one of the children trips and falls to her death on the rocks. There is a profound loss of a loved one but after the grieving, the surviving sibling is able to rebound and continue living well.

Now imagine another family not far from them, walking along the cliffs. The parents quietly discuss their intent to never have two children and push one child off the ledge to his death. The surviving sibling may not have witnessed them doing it but intuitively knows that it could have been her, leaving her with distress and guilt over being the one to have survived.

One was an accident, the other was intentional – this plays a crucial role in how sibling survivors perceive their place in the world.

Krista is intimately familiar with the complicated grief that arises from such a loss, "Sibling Survivors can really feel so ashamed that they are alive, and I certainly did."

She speaks of the suffering that she endured feeling rejected and abandoned by her father even from the womb that stemmed not only from his leaving but from his insistence that her mother abort Krista. She calls this her signature wound and yet, her sibling's death impacted her in a deeper way.

"To find out I had a sibling die by abortion, even with all the suffering that I had experienced, I still felt I had a life though, my sibling didn't.

Why me? Why am I here? Why is my sibling not here? Why do I get to laugh? Why do I get to have friends? Why do I get to blow bubbles?," she wonders.

She notes that the five stages of grief framework given by the Kübler-Ross model, one that she references often, was never meant to be linear or sequential. Some siblings experience more of certain stages than others and not always in order.

Krista recommends Therese A.

Rando's book "How To Go On Living After Someone You Love Dies" as a starting point for healing from sibling loss. Among the six 'R' processes in Rando's literature, Krista agrees to some degree with Dr. Ney's observations that 'Reinvesting in life' can be much harder for survivors. But unlike Ney, she believes that it is entirely possible to overcome the trauma of PASS and live a full life. "Because of my faith, I cannot believe that it is impossible to reinvest," she insists, her virtue of hope on full display.

Krista's ministry is an example of that. "Showing sibling survivors that it is possible to reinvest in life - **Even** This Way is that for me. Walking

with people who have experienced that is part of it for me."

Her faith was an important part of her healing journey. And so was community: "We're all very communal and social creatures. Having trusted friends who love you and are willing to hold your hand in the darkness, ask you how you are, and see you and your suffering and also see that that's not the end of it for you is so important."

Krista states that Even This Way is neither a religious nor a pro-life organization, although her team includes people of various faith backgrounds. They are there to "acknowledge the experience and help heal sibling survivors of abortion. They are our focus, and we will walk with them on their journey no matter what."






#### Irena's Vow




